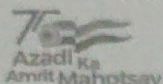





SITE PLAN OF LAND LEASE

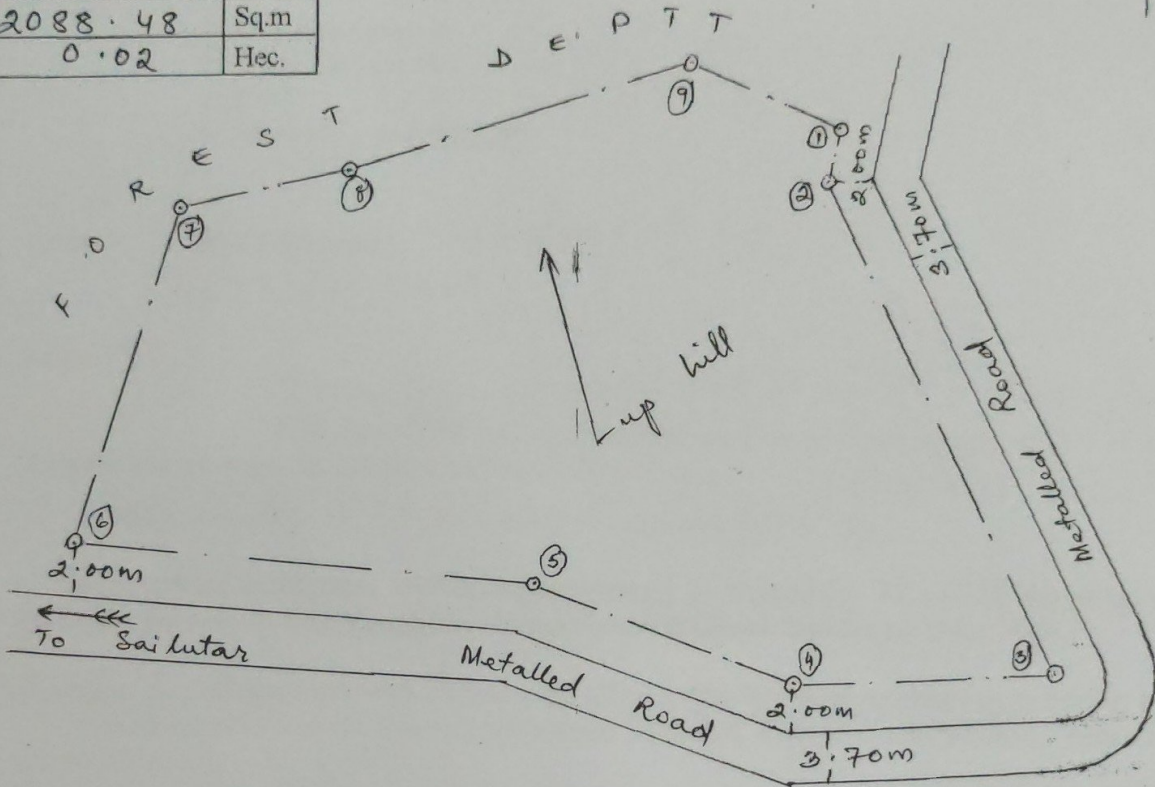
