Approval of DP&AR (ARW) and concurrence of Finance Department were obtained for filling up of the said vacancies vide I.D. No. ARW/FCS&CA-22/2022-2023/C-88 dt. 01.11.2022 and vide I.D. No. FIN (E) 805/2022 dated 16.11.2022.
