No.A.12026/6/2019-DTE(FCS&CA)/Estt/89: As per approval of Govt. conveyed vide No.A.11016/1/2021-FCS&CA dated 08.02.2023 and in accordance with this Directorate Advertisement No. 1 of 2023-2024 and in line with the Mizoram Ministerial Service (Competitive Examination) Regulations, 2023, Computer Typing Test, Written Examination and Computer Skill Test for direct recruitment to the vacant posts of LDC under FCS&CA Department were held on 9th to 13th October 2023, 6th December 2023 and 14th to 16th February, 2024 respectively. Out of the 32 (thirty two) candidates called, 31 (thirty one) candidates appeared for Personal Interview on 13th & 14th June, 2024.

On the basis of the aggregate marks obtained by the candidates in Written Examination as well as Personal Interview, the DPC recommended the following candidates in order of merit for appointment to the post of LDC under FCS&CA Department in the Level 4 of the Pay Matrix.
