

(2) राज्य आयोग का प्रत्येक सदस्य और जिला आयोग का अध्यक्ष और प्रत्येक सदस्य चार वर्ष की अवधि के लिए या पैंसठ वर्ष की आयु तक, जो भी पहले हो, पद धारण करेगा और पैंसठ वर्ष की आयु-सीमा के अध्यक्षीन अगले चार वर्ष के कार्यकाल के लिए पुनर्नियुक्ति के लिए पात्र होगा और ऐसी पुनर्नियुक्ति चयन समिति की सिफारिश के आधार पर की जाएगी।

NOTIFICATION

New Delhi, the 15th September, 2022

G.S.R. 704(E).—In exercise of the powers conferred by sections 29 and 43, read with clauses (n) and (w) of sub-section (2) of section 101 of the Consumer Protection Act, 2019 (35 of 2019), the Central Government hereby makes the following rules to amend the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020, namely: -

1. (1) These rules may be called the **Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) (Amendment) Rules, 2022.**

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and members of the State Commission and District Commission) Rules, 2020, for rule 10, the following rule shall be substituted, namely:—

10. Term of office of President or Member.— (1) The **President** of the State Commission shall hold office for a term of **four years or upto the age of sixty-seven years**, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty-seven years, and such reappointment shall be made on the basis of the recommendation of the Selection Committee.

(2) Every member of the State Commission and the **President** and every member of the District Commission shall hold office for a term of **four years or upto the age of sixty-five years**, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty-five years, and such reappointment shall be made on the basis of the recommendation of the Selection Committee.
