**Terms of Reference of the State Consumer Protection Council:**

Objects of the Council shall promote and protect the rights of Consumers in the State such as:-

- a) Rights to be protected against the marketing of goods and services which are hazardous to life and property.
- b) Rights to be informed about the quality, quantity, potency, purity, standard and price of goods or services so as to protect the consumers against unfair trade practices.
- c) Rights to be assured whatever possible, access to a variety of goods and services at competitive prices.
- d) Rights to be heard and to be assured that consumers' interests will receive due consideration at appropriate forums.
- e) Right to seek redressal against unfair trade practices or restrictive trade practices or unscrupulous exploitation of consumers; and
- f) Rights to consumer education.

The term of members of the Council shall be 3 (three) years subject to extension from time to time and they will be entitled to travelling and daily allowances as laid down in Rule 4(6)(a)(b)(c) of the Mizoram Consumer Protection (State Council & District Council) Rules, 2023.
