1. Gas lakna atanga consumer pakhat in subsidy a dawn hi khawi atanga sum hmuh hmanga pek nge? Engtik atangin nge Mizoramah kalpui tan a nih?

Chhanna: Gas subsidy hi India Sawrkar ruahman angin National Payment Corporation of India in a pek chhuah hna a thawk a ni. Mizoram-ah pawh India Sawrkar ruahman angin 1st April, 2015 atangin hman tan a ni.
