**MINUTES OF THE MEETING OF THE STATE PURCHASE ADVISORY BOARD
(SPAB) HELD IN THE CHIEF SECRETARY'S CONFERENCE ROOM ON
23.11.2021 AT 2:00 P.M**

A meeting of the State Purchase Advisory Board (SPAB) was convened under the chairmanship of Dr Renu Sharma, IAS, Chief Secretary, Government of Mizoram on 23.11.2021 at 2:00 P.M to consider the Expressions of Interest for carriage of Foodgrains and PDS commodities submitted by 48 persons along 127 main routes and 107 persons along 111 district routes. We coming the members, the chairperson requested the Secretary to present the agenda items for discussion. She raised certain queries on issues relating to the agenda points and the system of movement of PDS commodities within the State, which were clarified. The Member-Secretary informed the Board that due to the surge in COVID-19 cases this year and other unanticipated problems such as the blockade of entry points (including railway lines) from Assam on account of the inter-state border tension, FCS&CA Department was hard-pressed into channelizing all its available manpower, time and resources towards sourcing the State's POL and LPG requirements as well as essential commodities from Tripura, and in maintaining uninterrupted flow of foodgrains and essential commodities within the State. As a result, the existing period of contract which expired on 16.05.2021 had to be extended several times, the last extension being upto 16.11.2021. The Member-Secretary, therefore, sought condonation of the excess period of extension of the contract period with the existing contractors till the finalisation and implementation of the SPAB's recommendation.


The SPAB was also apprised that the willingness/EOI submitted by the interested persons had been scrutinised at the Directorate level and were found to be in accordance with the terms and conditions prescribed in the advertisements issued through leading newspapers as well as on the Department's website. The agenda note and related documents were duly examined and discussed. After a thorough deliberation, the SPAB approved the empanelment/appointment of 48 carrying contractors for transportation of foodgrains and PDS commodities along 127 main routes and 107 carrying contractors along 111 district routes for a period of one year as per the approved terms and conditions.



The re-appointment of ZIDCO Ltd as supplier for Grade 'A' rice and MIZOFED Ltd as supplier for sugar (F30) was admitted as an additional agenda. Given the fact that ZIDCO Ltd and MIZOFED Ltd are public sector enterprises, and the proposed price for supply of the rice and sugar remaining the same, the SPAB recommended their re-appointment for a period of one year with effect from 26.09.2021, upon expiry of the period of extension of the contract agreement on 25.09.2021 subject to the following conditions:


1. That ZIDCO Ltd will continue to supply the Grade 'A' rice at a price not exceeding the existing rate of Rs. 2750/- per quintal to be delivered to the Departmental godown at GMG, Zuangtui or any other supply centre as specified by the Department from time to time.
2. That MIZOFED Ltd will continue to supply sugar (F30) at the existing rate of Rs. 1500/- per quintal to be delivered to the Departmental godown at GMG, Zuangtui or any other supply centre as specified by the Department from time to time.




