**No.B.13015/4/2016-FCS&CA/68** : In the interest of Public Service and with the introduction of ePOS under End-to-End computerization of Targeted Public Distribution System, the Governor of Mizoram is pleased to constitute District Selection Committee for appointment of Fair Price Shop Dealer (Retailer) as indicated below with immediate effect and until further order.

**TERMS OF REFERENCE FOR SELECTION COMMITTEE**

1. The concerned DCSO should make wide publicity for selection of candidates of Fair Price Shop Dealership
2. The Committee should carefully scrutinize all the applications received by them and call all eligible candidates for personal interview.
3. The Committee should consider all factors such as education qualification, financial soundness, storage point and capacity of godown for all the candidates at the time of interview and weightage may be given in such manner decided by the selection committee.
4. The Committee should give preference to Cooperative Societies, Self Help Group etc., if any.
5. Final Selection List shall be made from amongst the candidates in the order of merit. The Committee shall make and put a list of candidates in descending manner.
6. In case, where the first applicant/the existing FPS dealer is disqualified due to certain reason and quits the job by himself in the middle or before the end of his/her term. The Committee may consider the next candidate and may award or offer the job to continue the work of remaining terms, if deems fit.
7. If sustainable candidate is not found through selection process, wider publicity for selection of FPS Dealers may be given by concerned DCSO.

## ELIGIBILITY CRITERIA FOR CANDIDATES

1. The applicant must be a citizen of India.
2. The applicant must be permanently residing in the Local Council or Village Council concerned.
3. The applicant should have storage premise with sufficient capacity for quota of the area for running as FPS Dealer.
4. Financial soundness should be taken into account while awarding FPS dealer. To prove financial soundness, the applicant should have available balance in his/her Bank account worth at least Rs.2.00 lakhs.
5. The applicant must have technical know how at least operation of ePOS Machine.
