**NOTIFICATION**

**No.B.12018/1/2020 - FCS&CA:** In the interest of Public service, the Governor of Mizoram is pleased to amend para 3.1, 3.2, 3.3 and 3.3(i) of Supply Manual, 2008 regarding Appointment of Carrying Contractor, Notice of inviting Tender and General Principles to be followed while entering into contract as under :-

**Para 3.1: Appointment of Carrying Contractor** : For transportation of food grains and other essential commodities from Railheads Or Base Depots of the Food Corporation of India **or from other Agencies other than Government Agencies** to Departmental Godowns, Carrying Contractors shall be appointed by inviting competitive tenders **or to invite any Willingness/Expression of Interest (EoI) from any person willing to enter into contract** for different routes. Normally such contracts shall be made on annual basis. **It is open for the Department to extend the term of carrying contractor in exigencies resultant upon unavoidable circumstances for a period of 6(six) months subject to a maximum of 12 (twelve) months.** The process for appointment of carrying contractor shall be initiated well ahead of the expiry of the current year's contractual period so that no complication develops for taking over the work by the newly appointed contractors from the stipulated date.

**Para 3.2: Notice of inviting Willingness/Expression of Interest** : No notice inviting Tenders **or Expression of Interest/Willingness** shall be floated or contract made by any authority that is not specifically authorized to do so by the Governor of Mizoram under the provision of the Article 299(1) of the Constitution of India.

**Para 3.3: General Principles to be followed while entering into contract** : For all notice inviting Tenders **or Expression of Interest/Willingness** and finalization of the contract, the following instructions shall be observed :-

**Para 3.3(i):** In selecting the tender **or expression of interest/willingness** to be accepted, the financial status of the individuals and tendering firms must be taken into consideration in addition to all other relevant factors.
