NOTIFICATION

No.A.12018/5/2016-P&AR(GSW) the 24th February, 2017. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to amend the Mizoram Food, Civil Supplies & Consumer Affairs Service Rules, 2012 (hereinafter referred to as the Principal Rules) which was notified vide No.A.12018/62/2007-P&AR(GSW) dated 09.04.2012, and published in the Mizoram Gazette Extraordinary Issue No. 184 dated the 12.04.2012, namely

- 1. Short title and commencement
 - (1) These Rules may be called the Mizoram Food, Civil Supplies & Consumer Affairs Service (Amendment) Rules, 2016.
 - (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. Amendment of Rule 3
 - (1) In the Principal Rules in Rule 3, the words "Mizoram Food & Civil Supplies Service (MF&CSS)" shall be substituted by the words "Mizoram Food, Civil Supplies & Consumer Affairs Service"

1. Amendment of Rule 7
In the Principal Rules, Rule 7 shall be substituted as follows, namely :-

- "1) Appointment to any post after initial constitution of the Service under rule 3 in Grade-V of the Service, shall be made as follows :
 - a) 50% of the total sanctioned posts by promotion through selection method from Sub-Inspector of Supplies with not less than 5 years of regular service in the grade.
 - b) 50% of the total sanctioned posts by direct recruitment from candidates holding degree of a recognised University to be conducted by the Commission failing which by deputation from Officers under Central/State Government holding analogous posts.

c) Out of the 50% direct recruitment quota, 3% shall be reserved for persons with disabilities having requisite qualification and as per physical requirement and functional classification identified by the Government.

2) The Commission shall conduct written examination and interview for selection of candidates within the direct recruitment quota and shall prepare and furnish the list of candidates recommended for appointment in order of merit to the Government"

Amendment of Rule 15

Sub-rule (1) and (2) of Rule 15 of the Principal Rules shall be substituted as follows, namely,

"(1) GRADE-I : The post in this grade as specified in Schedule-II shall be filled up by promotion through selection method from a member of the service in Grade-II who has rendered at least 5 years of regular service in the grade failing which Officers on regular service in Grade-II who has completed 15 years of regular service calculated from the date of entry into Grade-V of the service out of which at least 2 years of regular service in Grade-II.

(2) GRADE-II : The post in this grade as specified in Schedule-II shall be filled up by promotion through selection method from a member of the service in Grade-III who has rendered at least 5 years of regular service in the grade failing which Officers on regular service in Grade-III who has completed 10 years of regular service calculated from the date of entry into Grade-V of the service out of which at least 2 years of regular service in Grade-III"
