No.A.12018/32/2016-P&AR(GSW), the 18th April, 2019. In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram is pleased to make the following rules regulating the method of recruitment to the post of Accounts Officer under Food, Civil Supplies & Consumer Affairs Department, Government of Mizoram namely :-

- 1. Short title and commencement
- These rules may be called the Mizoram Food, Civil Supplies and Consumer Affairs Department (Group 'A' posts) Recruitment Rules, 2019
- These rules shall come into force with effect from the date of issue of notification for amalgamation and upgradation i.e. 11th December, 2017
- 2. Application

These rules shall apply to the post specified in Column I of Annexure-I hereto annexed.

3. Number of posts, classification and Level in the Pay Matrix

The number of the said post, classification and Level in the Pay Matrix attached thereto shall be as specified in Column 2 to 4 of the aforesaid Annexure-I

4. Method of recruitment, age limit and other qualifications

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in Column 5 to 14 of

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates bolonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disqualification

No person -

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- who, having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post(s):

- 7. Power to transfer
- 8. Power to relax
- 9. Reservation and other concessions
- 10 Repeal & Savings

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of these rules.

Every Government servant recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Notwithstanding anything contained in these rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officers, so recruited under these rules to any other post or position which is equivalent in rank or grade.

Where the Governor is of the opinion that it is necessary or expedient to do so, he may, by order and for reasons to be recorded in writing, in consultation with the Mizoram Public Service Commission through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other categories of persons in accordance with the orders issued by Central Government or Government of Mizoram from time to time in this regard.

All rules pertaining to the post of a) Accounts Officer notified by the Government of Mizoram vide No.A.12018/6/87-PAR(GS) dated 19.07.1988 and published in the Mizoram Gazette extraordinary issue No. 85 dated 19.07.1988 and b) Superintendent of Accounts notified by the Government of Mizoram vide No.A.12018/6/87-PAR(GS) dated 15.01.1992 and published in the Mizoram Gazette extraordinary issue No. 6 dated 15.01.1992 stand hereby repealed with effect from the date of commencement of these rules

Provided that any order made or anything done or any action taken under the rules so repealed or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
